The authorised fund manager of the Fund is Legal & General (Unit Trust Managers) Limited (the "Manager").

#### **OBJECTIVES AND INVESTMENT POLICY**

- The objective of the Fund is to provide income and growth above those of the ICE BofA BB-B Global High Yield Non-Financial 2% Constrained Index (Hedged to GBP), the "Benchmark Index". The Fund aims to outperform the Benchmark Index over rolling three year periods after the deduction of all fees and expenses.
- The Fund is actively managed and will invest in bonds (a type of loan that pays interest). These bonds will have a pre-set rate of income (either set at a fixed level or varying in a pre-determined way).
- The Fund will invest at least 70% in sub-investment grade bonds in sterling or bonds issued in currencies and hedged back to sterling. Sub-investment grade bonds are bonds that have achieved a lower credit rating from a nationally recognised statistical rating organisation or non-rated bonds that are deemed equivalent by the Manager. Credit ratings give an indication of how likely it is that the issuer of a bond will be able to pay back interest and the loan on time. The Fund is not constrained by the Benchmark Index and, as such, there are no restrictions on the extent to which the Fund's portfolio may deviate from the ones of the Benchmark Index. The bonds that the Fund invests in will be issued by companies or governments anywhere in the world.
- The Fund may also invest in money market instruments (such as treasury bills), cash, deposits and collective investment schemes, including those managed or operated by the Manager or an associate of the Manager.
- The Fund may use derivatives (contracts which have a value linked to the price of another asset) to:

- · reduce risk or cost: or
- generate additional capital or income with no, or an acceptably low, level of risk



- The Fund is in category 5 because it invests in company or government bonds which are sensitive to changes in interest rates, inflation and credit. This can be driven by political and economic changes and other significant events and may cause the value to go up and down. Bonds that are closer to their maturity date tend to be more stable in value. Bonds are generally considered to be higher risk investments than cash, but lower risk than company shares.


**Dilution adjustment:** On any day, the prices for buying or selling units in this Fund are the same. The Fund manager calculates a single price for this Fund based on the mid-point between the buying and selling prices of the Fund's assets. In certain circumstances, the Fund manager can adjust this price to account for whether there is more money going into or coming out of the Fund. This is called a 'dilution adjustment'

This can vary but as an example for this Fund we estimate 0.50% for purchases and 0.50% for sales at 31 December 2023. The amount of the

dilution adjustment may differ in future.
