- To obtain the exposure to shares in companies, bonds, cash and money market instruments, the Manager may invest directly or indirectly in collective investments schemes (both active and index tracking) including those which are managed and operated by the Manager or an associate of the Manager
- At times the Fund could hold:
- up to 100% in other funds; or
- up to 100% directly in the assets.
- The bonds that the Fund invests in may be: investment grade (rated as lower risk); or
- sub-investment grade (rated as higher risk).

 The Fund may have underlying investments that are valued in currencies that are different from GBP. Exchange rate fluctuations will impact the value of your investment. 
CHARGES
