Objective and Investment Policy

Investment Objective: To provide capital growth in the long term by investing in a combination of asset classes including equities, fixed income, property and cash with the potential for high levels of price fluctuations.

Investment approach

- Multi-asset approach, combining asset allocation with bottom-up expertise leveraged from specialists from JPMorgan Asset Management's global investment platform
- Actively managed implementation of strategies across asset-classes including equities, fixed income, property and cash, with the potential for high levels of price fluctuations

Investment Policy: The Fund may invest either directly or via collective investment schemes, which may be managed by the Investment Adviser or any other member of JPMorgan Chase & Co., in a broad range of assets globally, including emerging markets. Such assets may include equities (including smaller companies), fixed income (including investment grade and non-investment grade, high yield and emerging market debt), property and cash and cash equivalents.

The Fund may invest from 30% to 95% of its assets in equities, up to 45% in government bonds, up to 30% in corporate bonds, up to 20% in property and may hold up to 40% in cash and cash equivalents.

Benchmark: The benchmark of the Fund is 37.5% MSCI All Country World Net Total Return Index (GBP hedged), 37.5% FTSE All Share Net Index, 12.5% Bloomberg Global Aggregate Bond Index (GBP hedged), 12.5% Bloomberg Sterling Aggregate Bond Index.

The Fund is actively managed. The Benchmark is a Performance Comparator for the Fund and the Fund may bear little resemblance to its Benchmark. The Benchmark has been chosen as it reflects the main investment universe and strategy.

Distribution Policy: This Share Class will reinvest income.


