Objectives and Investment Policy

Lazard Digital Health Fund (the "Fund") aims to achieve long-term capital appreciation.

The Fund is actively managed and will pursue its objective by investing in the equities (i.e. shares) and equity related securities (i.e. shares including common and preferred stock, warrants and rights) of companies that the Investment Manager has identified as Digital Health Companies (being those that are well positioned to benefit from paradigm shifts in health care resulting from innovative scientific and technological breakthroughs that disrupt the health ecosystem).

The Fund will typically invest in companies having greater than US\$500m market capitalisation at the time of purchase and the Fund will usually hold between 20 and 40 such companies at any one time.

The Fund's investment in equity securities may include investment in China A-Shares acquired through either the Shanghai –Hong Kong Stock Connect or the Shenzhen –Hong Kong Stock Connect.

Through investment in Digital Health Companies, the Fund seeks to achieve the following social and environmental objectives: greater affordability and access to healthcare; improve customer healthcare data; and improve medical ethics and standards followed by Digital Health Companies. Digital Health Companies are rated in categories, to create an overall ESG score for each Digital Heath Company.

The Fund may invest up to 20% of its assets in companies located in emerging markets. The Fund may also invest up to 10% of its value in units or shares of other investment

funds (including exchange traded funds). The Fund may invest in cash and in investments that are deemed to be nearly equivalent

to cash at any time and to the extent considered appropriate in light of market conditions. The Fund may gain exposure to the asset classes above either by investing in them

directly, or by using derivatives (which are financial contracts whose value is linked to the

price of an underlying investment). The currency exposures of the Fund's portfolio will be substantially hedged back into USD, being the base currency of the Fund. As a result of its use of derivatives, the Fund may be 'geared' or 'leveraged' (which can lead to a proportionately much larger movement in the value of the Fund's assets). The expected level of the Fund's leverage will be 5% of the value of the Fund.

You can buy and sell shares in the Fund on any day on which the stock exchanges in London and New York are open for business.

The Fund has discretion as to which investments it will hold within the limits of the Investment Objective and Policy.

Income and profits, if any, attributable to your shares will not be paid out as a dividend but will be accumulated in the Fund on your behalf and reflected in an increase in the value of your holdings.

The Fund's performance is measured against the performance of the MSCI World Total Return USD Index and the MSCI World Health Care Net Total Return USD Index (together the "Benchmarks"), which the Investment Manager have assessed to be the most appropriate Benchmarks for measuring performance. The Fund is not constrained by either of the Benchmarks as it has flexibility to invest in securities and asset classes not included in either Benchmark.

The Fund promotes environmental and/or social characteristics within the meaning of Article 8 of Regulation (EU) 2019/2088, the "SFDR Regulation".

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within a short period of time.

Risk and Reward Profile

The risk rating of this share class is calculated on the basis of historic volatility – i.e. how much the value of the underlying assets of the Fund has fluctuated over the last 5 years. As this share class does not have 5 years' performance data available, we have simulated the volatility, using a suitable proxy, based on historic data.

This share class has been placed in the risk category stated above, because based on the simulated historic data, the underlying assets within the Fund have shown high volatility.


