### **OBJECTIVES AND INVESTMENT POLICY**

- The objective of the Fund is to provide income by investing in a broad range of asset classes through collective investment schemes.
- The Fund will invest in a wide range of collective investment schemes (including collective investment schemes which are not regulated by the Other information: Financial Conduct Authority) that have exposure to shares in companies, bonds (a type of loan that pays interest), gold, property, cash, deposits and money market instruments (such as treasury bills).
- The Fund manager will select collective investment schemes that invest across all countries, currencies and sectors.
- The Fund aims to have between 20% and 60% of the assets in shares in companies and at least 30% of the assets in bonds and money market instruments
- The Fund will typically have higher exposure to assets the Manager believes will generate income than to assets that will grow in value, relative to other The collective investment schemes the Fund invests in may be actively
- managed or passively managed (for example, a fund that tracks a particular stock market index) and up to 50% of the Fund may be invested in schemes
- managed or operated by Legal & General. The Fund may also invest directly in shares in companies, bonds (issued by companies and governments), money market instruments (such as treasury bills), cash and deposits.
- The Fund may use derivatives (contracts which have a value linked to the price of another asset) to:

- reduce risk or cost; or
- generate additional capital or income with no, or an acceptably low, level of risk

- The IA Mixed Investment 20-60% Shares is a benchmark which is used as a performance comparator of the Fund. See the Past Performance section for further details
- Your units will be income units. Income from the Fund's investments will be paid out to you every three months (as dividends). This will reduce your capital growth accordingly.
- You can buy or sell units in this Fund on any business day. You need to You can buy or sell units in this Fund on any business day. You need to contact us with your instruction before 12 noon. This is the time we calculate unit prices for this Fund. If you contact us after 12 noon, the units will be bought or sold at the next business day's price. The Fund's base currency is denominated in GBP. This Fund is designed for investors looking for income from an investment in a broad range of asset classes through collective investment schemes.

- Although investors can take their money out at any time, this Fund may not be appropriate for those who plan to withdraw their money within five years. This Fund is not designed for investors who cannot afford more than a
- minimal loss of their investment.

- The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. - The Fund is in category 4 because the mix of different asset types in which the fund invests has a balancing effect on the rate at which the fund share price moves up and down. This type of fund is generally considered to be higher risk than one investing only in bonds and lower risk than one existing only in company shares.

The Fund may have underlying investments that are valued in currencies

that are different from GBP. Exchange rate fluctuations will impact the value of your investment. Currency hedging techniques may be applied to reduce this impact but may not entirely eliminate it.

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential return from your investment.



- Dilution adjustment: On any day, the prices for buying or selling units in this Fund are the same. The Fund manager calculates a single price for this Fund based on the mid-point between the buying and selling prices of the Fund's assets. In certain circumstances, the Fund manager can adjust this price to account for whether there is more money going into or coming out of the Fund. This is called a 'dilution adjustment'
- This can vary but as an example for this Fund we estimate 0.02% for purchases and 0.02% for sales at 31 December 2023. The amount of the dilution adjustment may differ in future.
