Objectives and Investment Policy

Investment Objective:

The Fund aims to provide growth and income on your investment over time.

Investment Policy:

The Fund will invest at least 51% of its assets in shares of companies of any size that are based in, or carry out most of their business, in Frontier market countries. The list of Frontier Market countries can be found in the Prospectus.


The Fund may also invest up to 10% of its assets in other funds, including HSBC funds and may invest in bank deposits, money market instruments for treasury purposes.

The Fund may use derivatives to manage exposure to these markets, gain exposure to other currencies, improve returns and help meet the Fund's objective. The Fund may use them for efficient portfolio management purposes.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is USD. The reference currency of this share class is GBP.

- The Fund is actively managed and does not track a benchmark. The reference benchmark for the Fund is MSCI Select Frontier & Emerging Markets Capped Net.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- The deviation of the Fund's performance relative to the benchmark is also monitored, but not constrained, to a defined range.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

Material risks not fully captured by the Risk and Reward Indicator:

 Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.

- Emerging Markets Risk Emerging markets are less established, and often more volatile, than developed markets and involve higher risks, particularly market, liquidity and currency risks.
- Exchange Rate Risk Changes in currency exchange rates could reduce or increase investment gains or investment losses, in some cases significantly.


The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.
