Objectives and Investment Policy

Lazard Commodities Fund (the "Fund") aims to seek long-term capital appreciation.

The Fund is actively managed and will seek to achieve its investment objective primarily by seeking exposure to a broad range of commodities across various commodity groups as well as in companies involved or operating in sectors related to the production, storage and/or delivery of commodities.

The Fund will seek to obtain this exposure through a blend of investments, including investment in commodity-related financial derivative instruments (limited to unfunded total return swaps which provides the Fund with exposure to a range of UCITS-eligible financial indices comprised of commodities futures); direct investment in exchange-traded commodities and exchange traded notes (unsecured or unsubordinated debt instruments that are traded on different exchanges); equities and equity-related securities (namely, common and preferred stock, ADRs, GDRs and warrants) in companies with a market capitalisation greater than US\$300 million and whose primary source of revenue is derived from the production, storage and/or delivery of commodities.

The Fund may invest more than 20% of its value in emerging market countries, up to 10% of its value in units or shares of other investment funds (including exchange traded funds and other sub-funds of the UCITS) and up to 5% in REITs (i.e. real estate investment trusts).

The Fund may invest in cash and in investments that are deemed to be nearly equivalent to cash at any time and to the extent considered appropriate in light of market conditions.

The Fund may gain exposure to the asset classes above either by investing in them directly, or by using derivatives (which are financial contracts whose value is linked to the price of an underlying investment). The currency exposures of the Fund's portfolio will be substantially hedged back into US Dollars, being the base currency of the Fund.

As a result of its use of derivatives, the Fund may be 'geared' or 'leveraged' (which can lead to a proportionately much larger movement in the value of the Fund's assets). However, in certain circumstances, the Fund's leverage could reach up to 10% of the value of the Fund.

You can buy and sell your shares in the Fund on any day on which the stock exchange in New York is open for business.

The Fund has discretion as to which investments it will hold within the limits of the Investment Objective and Policy.

Any distributions that are paid to you will normally be reinvested to buy further shares unless you have elected to receive payment in cash.

The Fund's performance is measured against the performance of the Bloomberg Commodity Total Return Index (the 'Benchmark'), which the Investment Manager has assessed to be the most appropriate Benchmark for measuring performance. The performance of the Fund seeks to exceed the Benchmark performance. The Fund is not constrained by the Benchmark as it has flexibility to invest in securities and asset classes not included in the Benchmark.

The Fund promotes environmental and/or social characteristics within the meaning of Article 6 of Regulation (EU) 2019/2088, the "SFDR Regulation".

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within a short period of time.

Please note, there are other risks that may not be reflected in the risk and reward categories above. Some of these risks are summarised below.


