
Invesco Global Targeted Returns Fund (the "Fund") A sub-fund of Invesco Funds (the "Umbrella Fund") Class Z (GBP hedged) accumulation - GBP (ISIN: LU1218207147) (the "Share Class")

The Fund is managed by Invesco Management S.A., part of the Invesco Group.

Objectives and Investment Policy

- The objective of the Fund is to achieve a positive total return in all market conditions over a rolling 3 year period. The Fund targets a gross return of 5% per annum above 3 month EURIBOR (or an equivalent reference rate) and aims to achieve this objective with less than half the volatility of global equities, over the same rolling 3 year period. There is no guarantee that the Fund will achieve a positive return or its volatility target.
- The Fund uses a broad range of investment ideas and techniques to gain exposure to a selection of assets across all economic sectors worldwide, such as shares of companies, debt instruments (issued by governments or companies), commodities and money market instruments.
- To ensure a prudent spread of risk and a diversified portfolio, a minimum of 5 individual investment ideas from a minimum of 3 different asset types will be held in the Fund at all times.
- The Fund may invest in debt instruments which are in financial distress (distressed securities).
- The Fund may make significant use of derivatives (complex instruments) in order to (i) reduce the risk and/or generate additional capital or income and/or (ii) meet the Fund's investment objectives by generating varying amounts of leverage (i.e. where the Fund gains market exposure in excess of the net asset value of the Fund).
- The Fund is actively managed and is not constrained by its benchmark, the 3 Month Euribor Index + 5%, which is used for comparison purposes. As the benchmark is a proxy for a money market rate, the overlap is not applicable.

- You can sell shares in the Fund on any Dealing Day (as defined in the Prospectus). You may not buy or switch into the Share Class unless you are an existing investor in the relevant Share Class, but this may change at any time.
- Any income from your investment will be reinvested.

Risk and Reward Profile



- The Share Class is in risk category 3 due to the rises and falls of its price or simulated data in the past.

Other Risks


- The value of investments, and income from them, can go down as well as up and you may not get back the full amount you invested.
- The Fund may use Bond Connect to access Renminbi instruments traded in Mainland China. This may result in additional liquidity risk and operational risks including settlement and default risks, regulatory risk and system failure risk.
- Shares of companies are generally considered high risk investments and may result in fluctuations in the value of the Fund due to external factors.
- As a portion of the Fund may be exposed to less developed countries, you should be prepared to accept large fluctuations in the value of the Fund.
- Changes in interest rates will result in fluctuations in the value of the Fund.
- The Fund may invest in distressed securities which carry a significant risk of capital loss
- Debt instruments are exposed to credit risk which is the ability of the borrower to repay the interest and capital on the redemption date.
- Investment in instruments providing exposure to commodities is generally considered to be high risk which may result in large fluctuations in the value of the Fund.
- Return on your investment may be adversely affected by variations in exchange rates.
- The Fund may use derivatives (complex instruments) for investment purposes which may result in the Fund being significantly leveraged and may result in large fluctuations in the value of the Fund. - The Fund may use Stock Connect to access China A Shares traded in Mainland China. This may result in additional liquidity risk and operational risks including settlement and default risks, regulatory risk and system failure risk.
- This Share Class is denominated in a different currency than that of the base currency of the Fund and may be hedged to mitigate against the effect of exchange rate fluctuations between the two currencies. However, this may not be achieved.

Charges
