Objective

To generate income and some growth over the long term (5 years or more) by investing in sterling-denominated bonds.

Performance Target: To achieve the return of the Markit iBoxx Sterling Overall Index plus 1% per annum (before charges).

Portfolio securities

- The fund may also invest in other bonds issued anywhere in the world, including high yield bonds (which are like loans to companies or governments that pay a high rate of interest but have a lower credit rating than investment grade bonds). The fund has some flexibility to seek returns from currencies.
- The fund may also inversit in other funds (including those managed by abrdn), cash and assets that can be turned into cash
