Fund performance may differ from the Benchmark Index due to the deduction of fees and expenses and the impact of any tracking error factors.

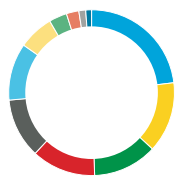

- **How does it invest?** Passively managed, aiming to replicate the performance of the Index.



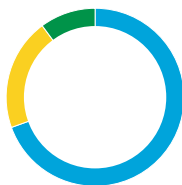
PORTFOLIO BREAKDOWN

INDEX FUND MANAGEMENT TEAM
