

Investment Objective

The Unicorn UK Smaller Companies Fund aims to achieve long-term capital growth by investing primarily in UK companies included within the Numis Smaller Companies plus AIM Index. For this purpose, UK companies are defined as those which are incorporated or domiciled in the UK, or have a significant part of their operations in the UK. The Index covers the bottom tenth by value of the main UK equity market plus AIM stocks that meet the same size limit.

Investment Policy/Strategy

The investment approach is to identify individual companies for investment and therefore the portfolio may not be representative of the index. AIM is the London Stock Exchange's International Market for smaller growing companies. The fund may also invest, at its discretion, in other transferable securities and deposits and cash. The fund may also enter into certain derivative and forward transactions for hedging purposes. The fund invests for the long term and there is no guarantee that any particular return will be achieved over any period. Investors should note that their capital is always at risk.

Fund Commentary

The UK Smaller Companies Fund recorded a total return of +0.8% in May, compared to the average total return of +2.3% from the IA UK Smaller Companies sector over the same period.

The primary contributor during the month was 4imprint, which added 0.5% to overall Fund performance. 4imprint released a strong trading update during the month, which reported on encouraging trends in trading.

The principal detractor during the period was Frontier Developments, which cost the Fund 0.8% in overall performance terms. Frontier released a major expansion to its longest standing game franchise, Elite Dangerous, during the month. Unfortunately, the reviews of the game expansion were broadly negative as players complained about various glitches. Frontier's game developers are working hard to release fixes that will improve the playability of the game, but the negative reviews are nonetheless disappointing and may negatively affect future sales.

There were no other material detractors from fund performance.

A position was initiated in Premier Foods during the month. Premier Foods is one of Britain's largest listed food companies and is the owner of a number of well-known brands, including Bisto, Ambrosia and Mr Kipling. The management team has implemented a significant restructuring of the business in recent years, which has resulted in improved organic growth and strong cash generation. This has enabled the business to reduce debt and reinstate dividend payments. Despite recent gains, the shares still trade at a material discount to sector peers. Positions in Marshalls and Bytes Technology were exited in full on valuation grounds.
