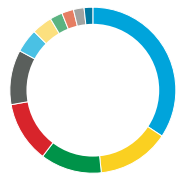
## FUND SNAPSHOT

- **How does it invest?** Passively managed, aiming to replicate the performance of the Index.



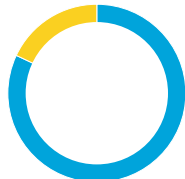
## PORTFOLIO BREAKDOWN

### INDEX FUND MANAGEMENT TEAM
