# **Investment Objective**

The Fund aims to achieve income and capital growth, by aiming to outperform (net of fees) the FTSE Actuaries UK Index-Linked Gilts All Stocks Index Midday Total Return (in GBP), over a rolling three year period. It invests directly in index-linked gilts, overseas index-linked government bonds, index-linked government guaranteed bonds, gilts, conventional government bonds, corporate and supranational bonds, or by gaining exposure indirectly through the use of derivatives. At least 80% of the Fund's assets will be invested in index-linked gilts issued by the United Kingdom Government. 



Maturity Breakdown (%) (weighted by market value)




## Sector Breakdown (%) (weighted by market value)
