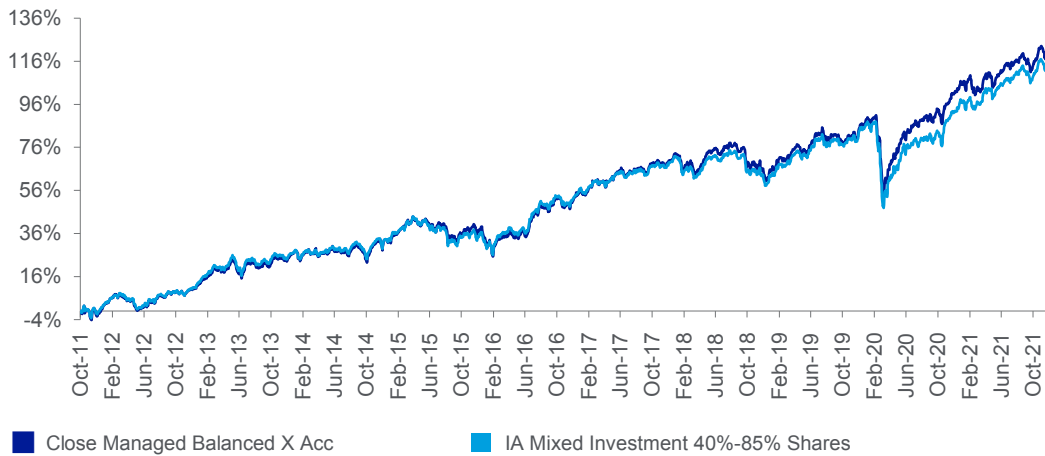
Fund objective
