## THE FUND

The Fund seeks to achieve capital growth and income with a below median level of volatility. The underlying funds in the portfolio invest globally (including in emerging markets) across asset classes and financial instruments. The underlying funds will be a blend of active and passive funds. The Fund typically has a lower exposure to higher risk assets and a greater exposure to lower risk assets compared to other funds in the Liontrust MA Blended Funds range that have a higher risk profile.

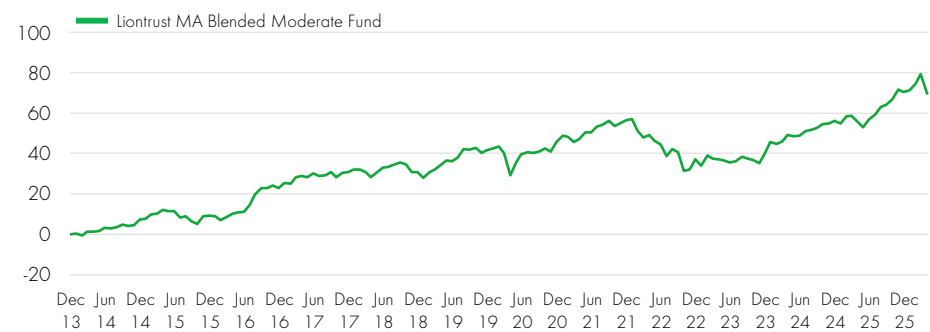

## PERFORMANCE SINCE CLASS LAUNCH DATE (%)



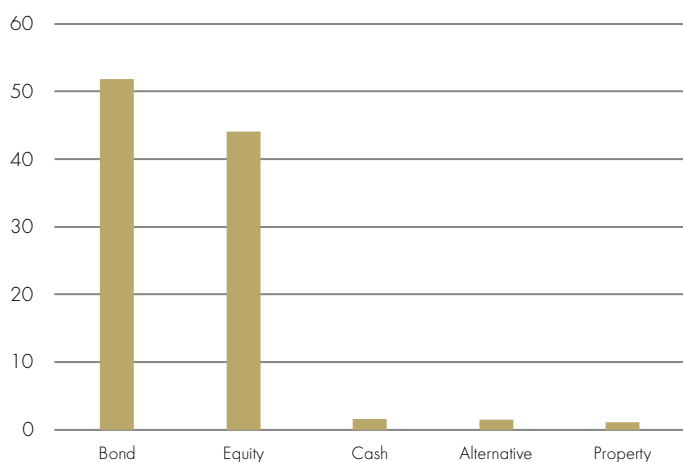
