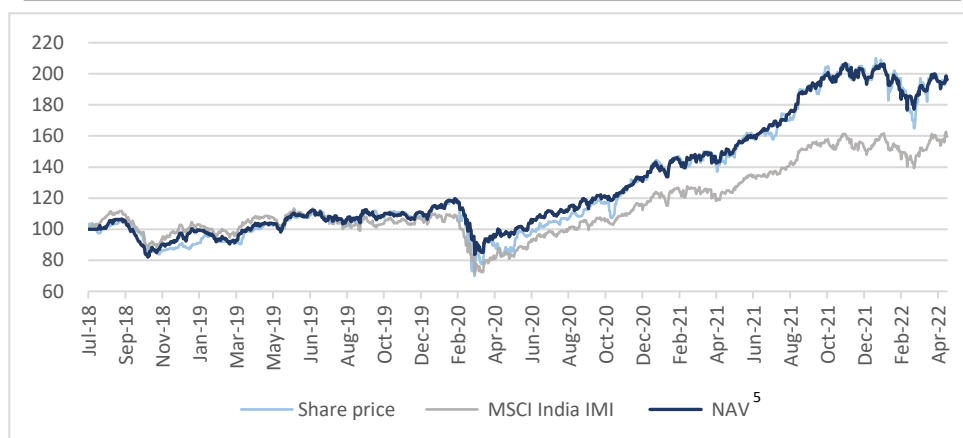

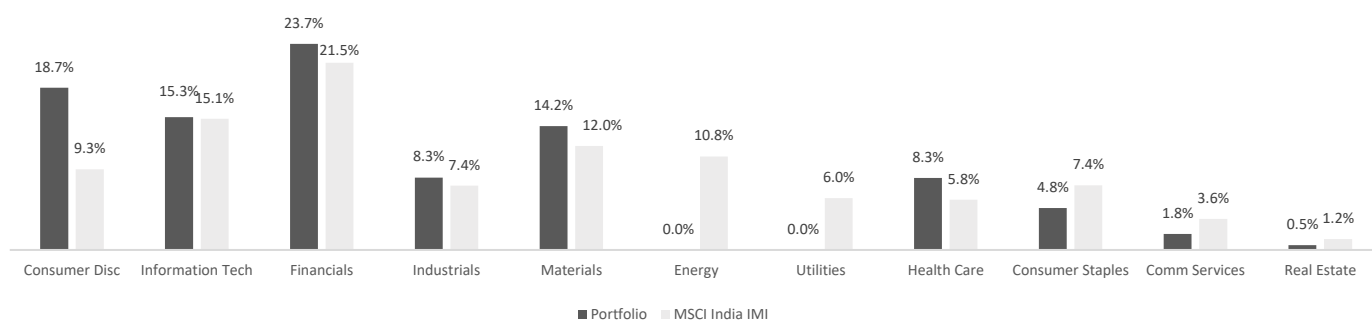

Market Review

In April, MSCI India IMI index was up 3.0%, outperforming most global indices. US equities (S&P 500) were down 4.7%, MSCI World was down 4.2%, and MSCI EM was down 1.4%.

FII's were net sellers to the tune of US\$3.8bn in April 2022 while net buying by local mutual funds was US\$3.0bn. For the month, the Rupee depreciated by 0.8% while the benchmark 10-year G-Sec yields rose from 6.8% to 7.2%.

Commodities were mixed, with Brent up 9% and the S&P GSCI Industrial Metals Index down by 3%.

Continuing their YTD strength, sectors such as utilities (MTD: 22.5%, YTD: 46.3%) and energy (MTD: 9.2%, YTD: 21.7%) outperformed the market. On the other hand, IT Services was a key underperformer during the month (MTD: -8.9%, YTD: -11.3%). Government owned companies continued to outperform (BSE PSU Index MTD: +6.5%, YTD: +15.5%).

Performance Review

The Fund was up 1.4% in April, underperforming the benchmark by -161bps. The key contributors include Laxmi Organic Industries (+8.8%), ICICI Bank (+5.8%), and Asian Paints (+9.3%) whereas Infosys (-14.5%), Mphasis (-12.5%), and Hindalco (-11.9%) were the key detractors.

Year-to-date, the fund is down 3.3%, underperforming the benchmark by -641bps. The key contributors include Cholamandalam Investment (+49.2%), Fine Organic Industries (+26.7%), and Cipla (+9.0%) whereas Truecaller (-51.3%), Coforge (-25.0%), and PB Fintech (-26.2%) were the key detractors.
