## Objectives and Investment Policy

The investment objective of the Fund is to provide an annual income and grow the value of your investment (known as "capital growth") over a rolling 5 year period, after the deduction of all fees.

Although the Fund aims to deliver capital growth over a rolling 5 year period, there is no guarantee that this will be achieved over this time period, or any time period. The Fund's capital is at risk meaning that the Fund could suffer a decrease in value and the value of your investment would decrease as a result.

At least 80% of the Fund will be invested in a global portfolio of equities (i.e. shares, including common and preference shares) in large companies anywhere in the world, including Emerging Markets. For these purposes, large companies are companies with a market capitalisation equal to or greater than \$5 billion.

The Fund is actively managed and will be invested in assets that in the opinion of the Investment Manager provide the potential for income and long-term capital growth. The Investment Manager uses quantitative screening to help identify and focus its research on under-valued companies that are expected to grow both earnings and dividends over time. The screening looks at relevant metrics such as current and estimated future earnings, estimated future dividend yield and current levels of debt.

The Investment Manager may invest in any market sector if the company meets its investment criteria. The Fund's investments are not restricted by reference to a benchmark or market sector limits.

Up to 20% of the Fund in total may be invested in: rights for shares, warrants, depository receipts (securities issued by banks that represent company shares), convertible bonds, deposits, cash and near cash and, subject to a limit of 10% of the Fund, collective investment schemes (which may include those managed by the ACD and its associates). Assets held as cash and near cash are not expected to exceed 5% of the Fund in normal market conditions, but this may be higher from time to time if the Investment Manager considers it to be in the best interests of shareholders (at all times subject to the preceding 20% limit).

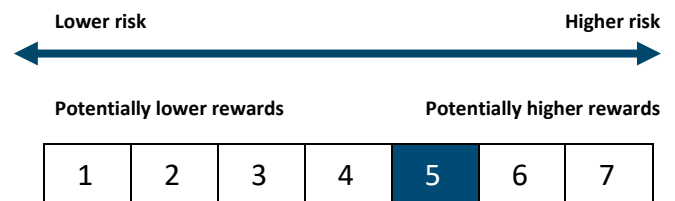
The Fund may use derivatives for the purposes of reducing risk or cost or for generating extra income or growth (known as "efficient portfolio management"). As an example, the Fund may use forward contracts for currency hedging with the intention of reducing the risk arising from currency exposures in a cost-effective way.

Dividend income for this share class is paid to investors as detailed in the fund's prospectus.

Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within 5 years.

## Risk and Reward Profile

The Risk and Reward Indicator demonstrates where the fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the fund. The shaded area in the table below shows the fund's ranking on the Risk and Reward Indicator.



The fund is ranked at 5 because funds of this type have experienced medium to high rises and falls in value in the past. The risk and reward score is based on past performance and calculated in accordance with European legislation. It may not be a reliable indication of the future risk profile. The risk and reward score is not guaranteed and may change over time. The lowest category does not mean risk free. While the risk indicator takes into account the broader risk profile, the following risks are considered most relevant to this fund:

**Equity Securities:** Equities can lose value rapidly, and typically involve higher market risks than bonds, money market instruments or other debt instruments. Fluctuation in value may occur in response to activities of individual companies, the general market, economic conditions, or changes in currency exchange rates.

**Liquidity:** There is a risk that adverse market conditions may affect the fund's ability to sell assets at the price the fund would like, or the fund may have to sell them at a loss.

**Overseas investment:** Investments by the sub-fund(s) in global equities issued by overseas companies may carry additional risks including exchange rate movements, political and economic upheaval, relative lack of information, relatively low market liquidity and the potential lack of strict financial controls and standards.

**Emerging Markets:** The Fund may hold investments in emerging markets which may be more volatile than investments in more developed markets. Emerging markets may have relatively unstable governments, economies based on only a few industries and securities markets that trade only a limited number of securities. Many emerging markets do not have well developed regulatory systems and disclosure standards may be less stringent than those of developed markets. The risks of expropriation, nationalisation and social, political and economic instability are greater in emerging markets than in more developed countries.

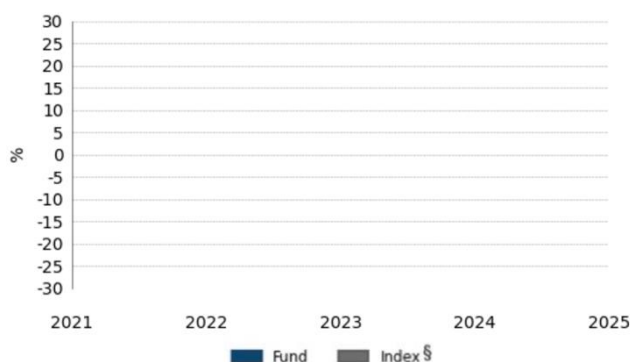
