The fund is managed by Morgan Stanley Investment Management (ACD) Limited, part of the Morgan Stanley group.

### OBJECTIVES AND INVESTMENT POLICY

#### Objective

- The Fund aims to grow your investment over 5 to 10 years.
- The Investment Manager will also apply ESG criteria that seeks to achieve a greenhouse gas ("GHG") emissions intensity for the Fund that is significantly lower than that of the reference universe.

#### Main Investments

- At least 70% of the Fund's investments will be in company shares in developed markets on a global basis.

#### Investment Policy

- To invest in a concentrated portfolio (typically 25-50 holdings) of high quality companies characterized by sustainably high returns on operating capital, powerful intangible assets such as brands, networks, licences and patents, and pricing power.
- The Fund includes: climate and weapons-related exclusions; a greenhouse gas (GHG) emissions intensity filter, and; other sector/industry restrictions, including alcohol and tobacco. - As an essential and integrated part of the investment process, the Investment Manager assesses relevant factors material to long term sustainable returns including environmental, social and governance (ESG) factors and seeks to engage with management teams as part of this. The Investment Manager retains discretion over which investments are selected. In exercising this discretion, ESG factors are not the sole determinant of whether an investment can be made or a holding can remain in the Fund's portfolio, but instead the Investment manager considers the impact of these ESG factors on the long term sustainable returns of an investment.

- The Fund may make use of exchange traded and over-the-counter options, futures and other derivatives for efficient portfolio management (including hedging) purposes. The Fund may also invest up to 30% of its assets in companies in emerging markets, including China A-Shares via Stock Connect.

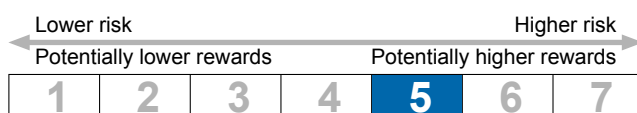
#### Other Information

- The reference universe is defined, only for the purposes of comparing GHG emissions intensity, as the MSCI AC World Index.
- The Fund's performance is compared against the MSCI World (Net) Index.
- Income will be included in the value of your shares.
- The Fund may invest up to 30% of its assets in other investments that do not meet the above criteria.

#### Buying and selling shares

- Investors may buy or sell shares on any London working day, or any other day if decided by the Authorised Corporate Director.

### RISK AND REWARD PROFILE

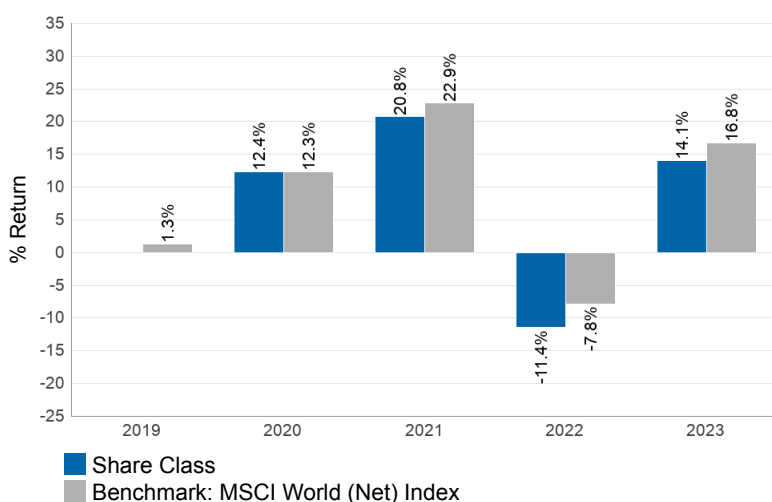
The entry and exit charges shown are maximum figures. In some cases you might pay less, you can find this out from your financial adviser.
