**BlueBay Funds - BlueBay Investment Grade Financials Plus Bond Fund, S - GBP (QIDiv) ISIN:LU2711051776, a class of sub-fund of BlueBay Funds managed by BlueBay Funds Management Company S.A.**

## Objectives and investment policy

The fund aims to make a return for you through a mixture of generating income and growing the amount you originally invested. It mainly invests in bonds issued by financial institutions that pay a fixed or variable interest.

The fund is actively managed, and does not reference any benchmark, while taking into account Environmental, Social and Governance (“ESG”) considerations. The fund targets to achieve a total return from a portfolio of investment grade-rated fixed income and subordinated debt securities issued by financial institutions. At least two-thirds of the fund's investment will be in fixed and floating rate, senior and subordinated bank debt obligations issued by financial institutions rated investment grade. Subordinated bank debt includes, but is not limited to Tier 1 and Tier 2 contingent convertibles (CoCos) and US perpetual preferred stock. The fund may not invest more than 20% of its net assets in CoCos, and up to 10% of its net assets in equity securities. The fund may invest up to 10% in aggregate of its net assets in fixed income securities rated below investment grade or unrated. Any security below investment grade may not be rated below B3/B-. In accordance with Article 8 of SFDR, the fund promotes environmental and social characteristics and investments which follow good governance practices. The environmental and social

characteristics promoted by the fund consist in favouring investment in issuers whose business activities and/or conduct take an appropriate and responsible approach to ESG. Further information on the environment and social characteristics promoted by the fund is available in Appendix 2 of the prospectus. The fund may use derivatives (such as futures, options and swaps, which are linked to the rise and fall of other assets) to obtain, increase or reduce exposure to underlying assets and may thus create gearing which may result in greater fluctuations of the value of the fund. The manager of the fund will ensure that the use of derivatives does not materially alter the overall risk profile of the fund.

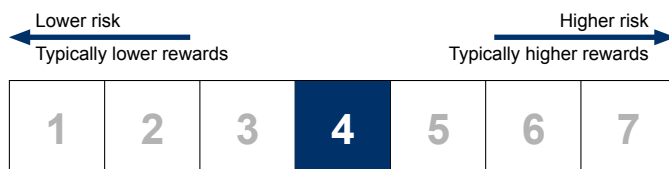
If you hold shares in a class that pays dividends we expect that any income generated by the fund will be paid out to you on a regular basis. For other share classes, any income the fund makes will be reinvested to grow your investment.

You can buy and sell shares every day which is a business day in London and Luxembourg, subject to the terms in the General Information section of the prospectus.

The fund may not be appropriate for investors who plan to invest for less than three years.

## Risk and reward profile

The Risk and Reward Indicator table shows where the class ranks in terms of its potential risk and return. The higher the rank the greater the potential reward but the greater the risk of losing money. The table uses a standard calculation method that is used by all companies who offer such funds within the European Union.



The shaded area in the table above shows the class's ranking based on the Synthetic Risk and Reward Indicator. It is based upon how much the price of the class has moved up and down in the past. The class is ranked at 4. Please note that using such past information may not reliably predict how the class will perform in the future. Its ranking is not guaranteed to remain unchanged and may shift over time. Even the lowest risk class does not mean the investment is risk free.

The Risk and Reward Indicator does not take into account the following:

- At times, the market for investment grade bonds or high yield bonds may dry up, which could make it difficult to sell these bonds, or the fund may only be able to sell them at a discount
- There may be cases where an organisation with which we trade assets or derivatives (usually a financial institution such as a bank) may be unable to fulfil its obligations, which could cause losses to the fund
- Investing in subordinated bank debt, including CoCos, offers you the chance to gain higher returns through growing your capital and generating income. Nevertheless, there is a risk that CoCos may 1) be converted to equities or permanently written down 2) not be redeemed by the issuer when expected 3) defer or cancel interest payments indefinitely, which would result in a loss of income to the fund and possible loss of its initial investment. Additionally, CoCo investors may suffer losses prior to investors in the same financial institution holding equities or bonds
- BlueBay's ESG analysis can rely on input from external providers. Such data may be inaccurate or incomplete or unavailable and BlueBay could assess the ESG risks of securities held incorrectly
- BlueBay could suffer from a failure of its processes, systems and controls – or from such a failure at an organisation on which we rely

in order to deliver our services – which could lead to losses for the fund

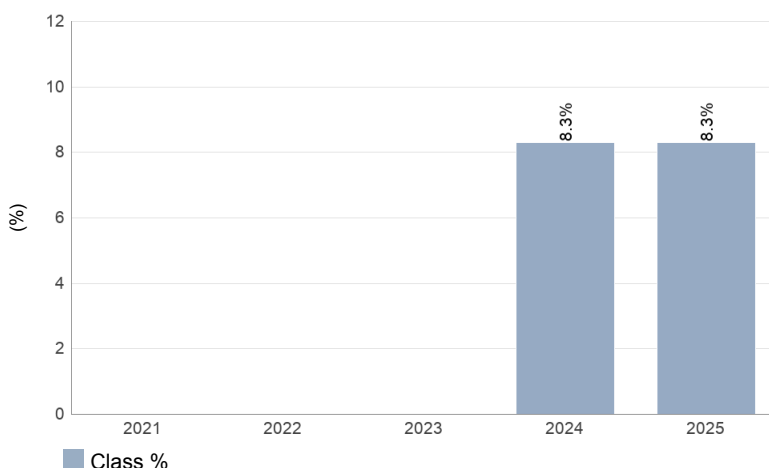
