## INVESTMENT OBJECTIVE

The fund aims to provide a return by way of income with some capital growth.

## INVESTMENT PROCESS

Our process begins with the formulation of a strategic asset allocation. This asset allocation is reviewed regularly based on our assessment of current economic, political and market conditions. These investment decisions are implemented predominantly with active and passive securities.

## WHAT YOU NEED TO CONSIDER

If you have a long time to grow your investments you might be able to ride out market ups and downs better than someone who needs their money in just 5 years. 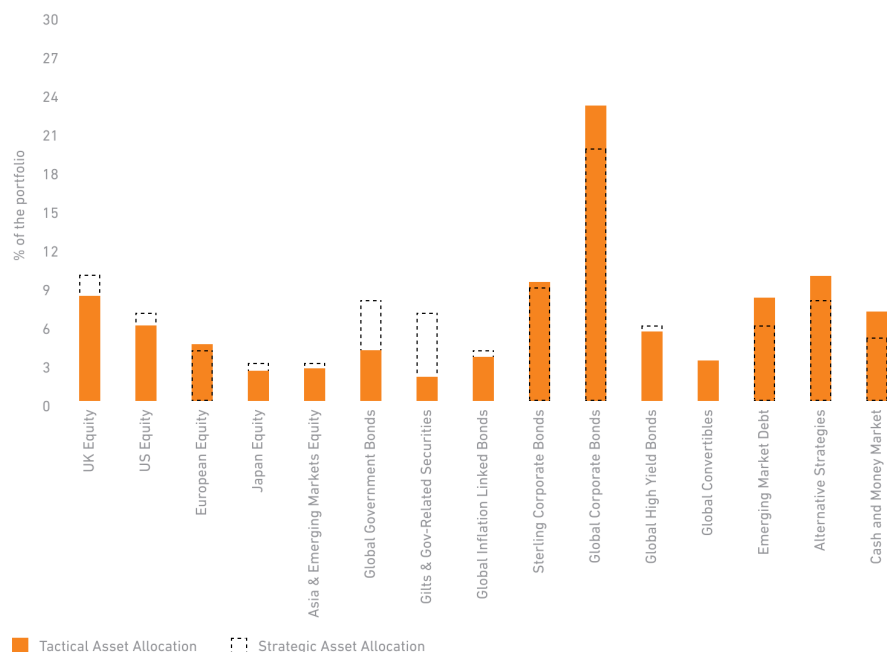

## TACTICAL ASSET ALLOCATION

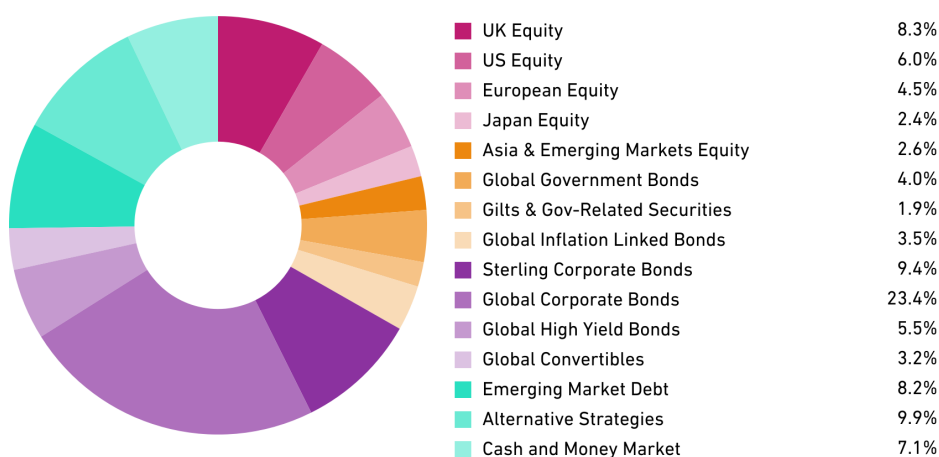
