#### **INVESTMENT OBJECTIVE**

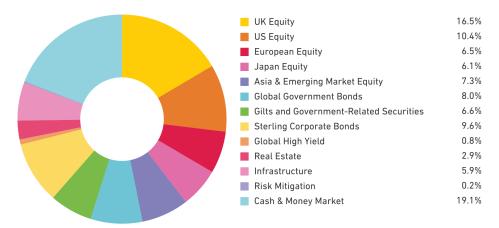
