Fund objective and policy

The Fund aims to achieve capital growth with some income. The Fund is actively managed. It is not constrained by its comparator benchmark, the IA Mixed Investment 20-60% shares sector median, and has significant freedom to invest in a portfolio that is materially different to the benchmark's own composition. 
