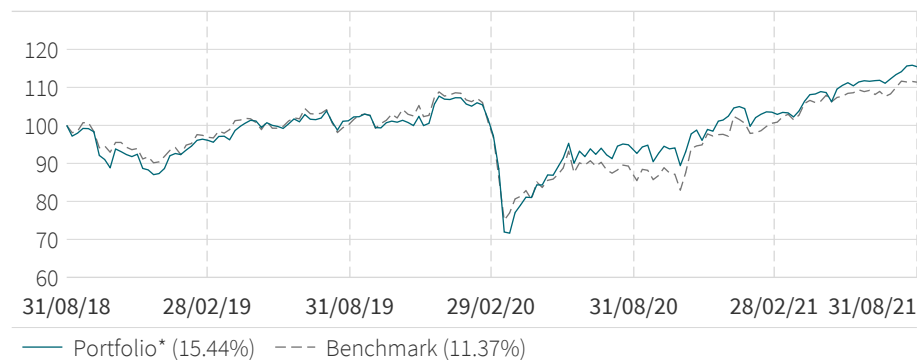

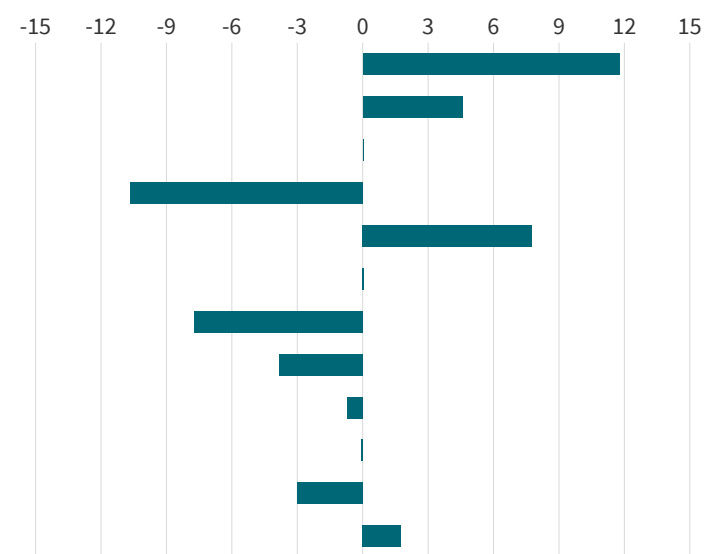

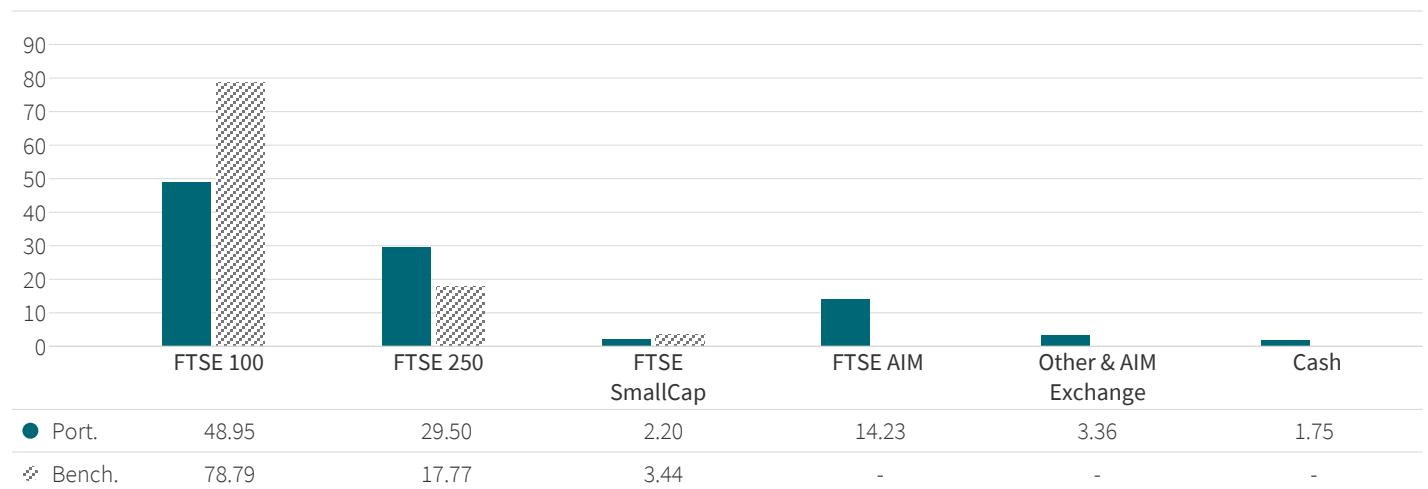

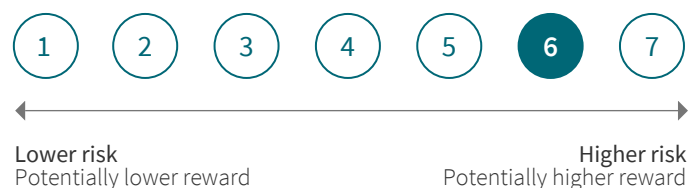
### Fund Objectives
