#### Objective


To generate income and some growth over the longer term (5 years or more) by investing in emerging markets corporate and/or government bonds.

**Performance Target:** To achieve the return of the JP Morgan EMBI Global Diversified Index (Hedged to GBP) plus 2.5% per annum (before charges). The Performance Target is the level of performance that the management team hopes to achieve for the fund. There is however no certainty or promise that they will achieve the Performance Target. #### Portfolio securities


#### Management process

- The management team use their discretion (active management) to identify bonds and derivatives
  after analysing company's prospects and creditworthiness alongside global economic and market
  conditions. They make flexible allocations across bonds and derivatives in emerging markets as
  well as currencies.
- In seeking to achieve the performance target, the JP Morgan EMBI Global Diversified (GBP Hedged) Index is used as a reference point for portfolio construction and as a basis for setting risk constraints. The expected variation (tracking error) between the returns of the fund and the index is not ordinarily expected to exceed 8.50%. Due to the active nature of the management process, the fund's performance profile may deviate significantly from that of the JP Morgan EMBI Global Diversified (GBP Hedged) Index.
