On 31 August 2020, Rhys Davies became a co-fund manager of the Invesco Monthly Income Plus Fund (UK).

Fund investment objective and policy

The objective of the Fund is to achieve income and capital growth over the medium to long-term (3 to 5 years plus). The Fund invests at least 80% of its assets in corporate and government debt securities (which may be investment grade, non-investment grade or have no credit rating) and shares of companies globally. The Fund may use derivatives (complex instruments) for investment purposes and to manage the Fund more efficiently, with the aim of reducing risk, reducing costs and/or generating additional capital or income.

Fund strategy

The fund's fixed income allocation is invested in a diversified portfolio of high yield and investment grade bonds. The volatility of financial markets through 2020 provided the opportunity to add yield across both of these areas of the market. The subordinated bonds of companies within the financial sector are currently the fund's largest exposure by sector. The fund retains a modest allocation to equities.

Investment risks

- As a result of COVID-19, markets have seen a noticeable increase in volatility as well
 as, in some cases, lower liquidity levels; this may continue and may increase these
