
Performance Comparator: IA Asia Pacific ex Japan Equity Sector Average.

Management process

- The management team use their discretion (active management) to maintain a diverse asset mix at country, sector and stock level.
- Their primary focus is on stock selection using research techniques to select individual holdings. The research process is focused on finding high quality companies at attractive valuations that can be held for the long term.
- In seeking to achieve the Performance Target, the MSCI All Countries Asia Pacific ex Japan is
 used as a reference point for portfolio construction and as a basis for setting risk constraints.
 The expected variation ('tracking error') between the returns of the fund and the index is not
 ordinarily expected to exceed 8%. Due to the active nature of the management process, the Fund's
 performance profile may deviate significantly from that of the MSCI All Countries Asia Pacific ex
 lapan.
