## Fund manager's report

- High yield markets continued to rally strongly in February, albeit at a slower pace. Strong demand from investors and inflows combined with little supply has made euro high yield retrace over 70% of the Q4 credit spread widening.
- Optimism on trade talks between the US & China and dovish central banks have continued to support risk assets. Economic data from the Eurozone continues to be weak.
- Overall, company results have been in line with expectations. Expectations have grown that a delay or soft Brexit is most likely and sterling high yield has enjoyed a belated rally.
