The Fund invests in companies incorporated, domiciled or which conduct significant business in the United Kingdom (UK). All investments will be expected to conform to our ESG criteria.

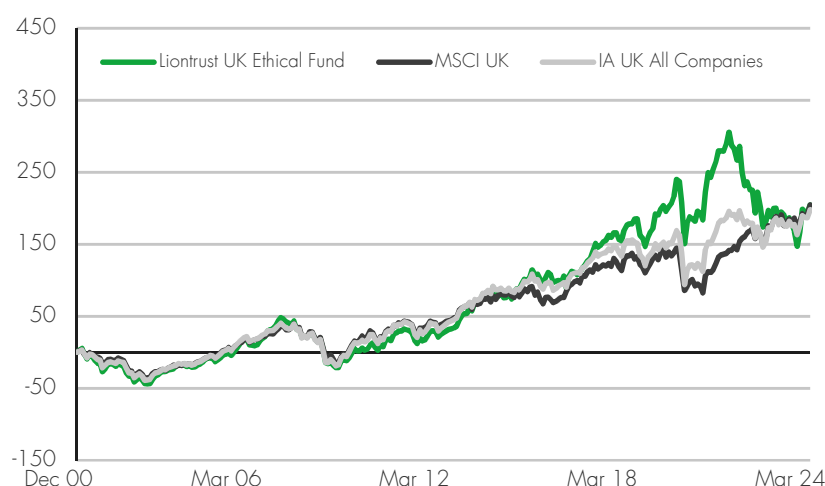
