### Objective

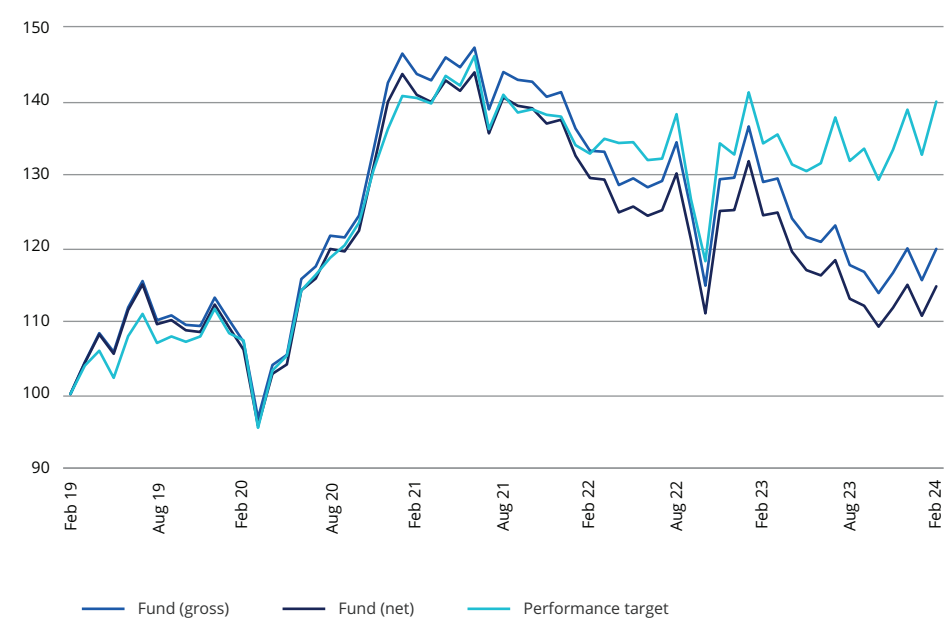
To generate growth over the long term (5 years or more) by investing in Asia Pacific, excluding Japan equities (company shares).

**Performance Target:** To achieve the return of the MSCI AC Asia Pacific ex Japan Index plus 3% per annum over rolling three year periods (before charges). There is no certainty that the Performance Target will be achieved. The MSCI AC Asia Pacific ex Japan Index (the "Index") is a representative index of the collective stock markets of Asia Pacific (excluding Japan).

### Portfolio securities

- The fund invests at least 70% in Asian (excluding Japan) equities.
- The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.

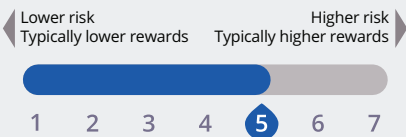

### Key risks

Management process

- The management team use their discretion (active management) to maintain a diverse asset mix at country, sector and company level.

The research process is focused on finding attractive high quality companies that can be held for the long term through the assessment of their business, the industry they operate in, their financial strength and the capability of their management team.
- Due to the active nature of the management process, the Fund's performance profile may deviate significantly from that of the Index over the long term.
