

IFSL atomos Balanced Fund

January-24 | Factsheet

On 21st April, Atomos Investments Limited (atomos) appointed Towers Watson Limited ("WTW") as sub investment manager of the Fund. The investment policy was also updated to reflect the fund moving from direct investment in securities to investment in other funds.

Overview

The Fund will be actively managed on a medium to high risk strategy, primarily through a fund of funds approach (which is a fund that invests into other funds). The Fund will gain exposure to between 50-80% in the shares of companies and up to 50% in bonds, covering a range of global markets. The Fund may also gain exposure to other asset classes such as money market instruments (which are shorter term loans), property and commodities. The aim of the Fund is to grow the value of your investment over a period of at least 5 years. This growth is expected to come from a combination of profit on investments and income paid out of investments, such as interest and dividends.

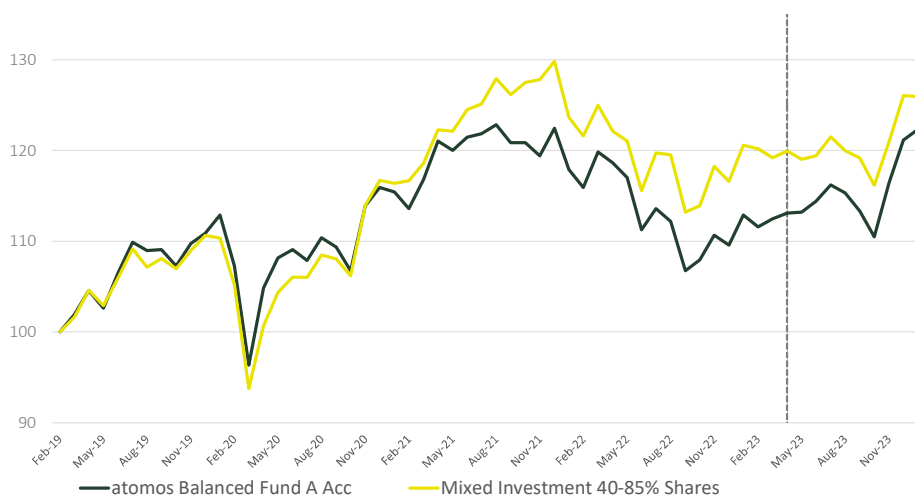

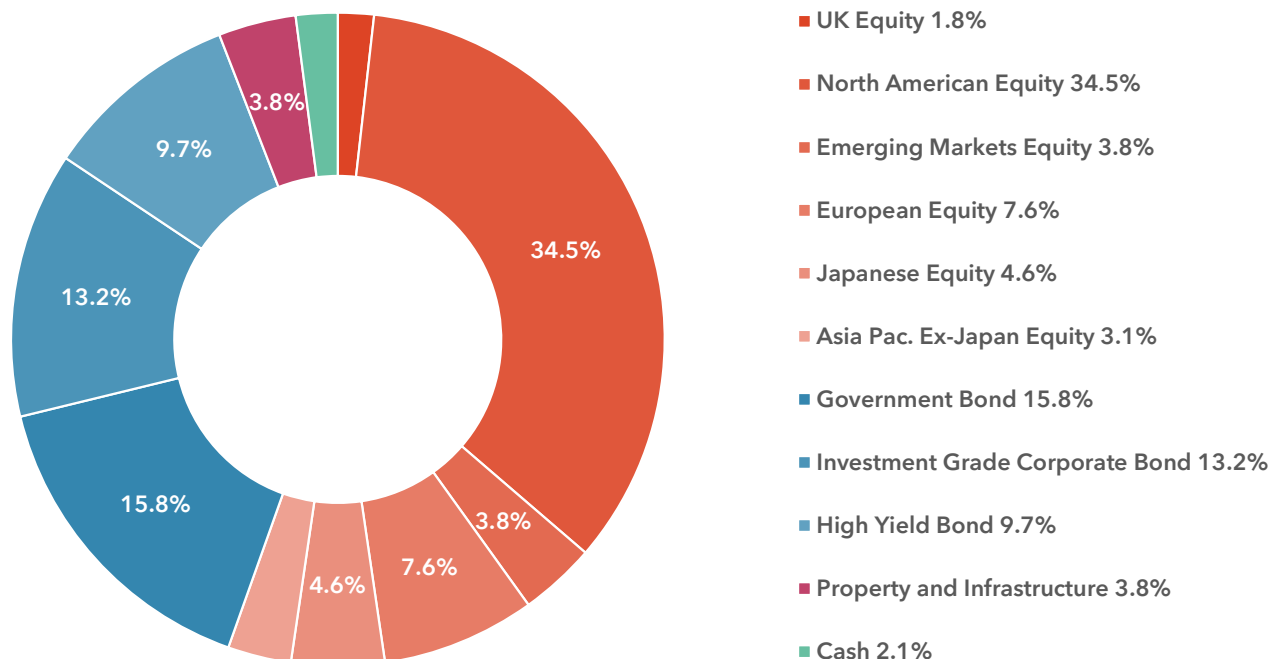
