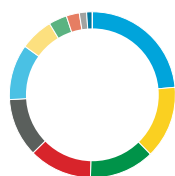

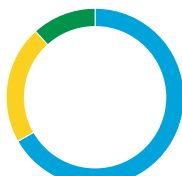
PORTFOLIO BREAKDOWN
