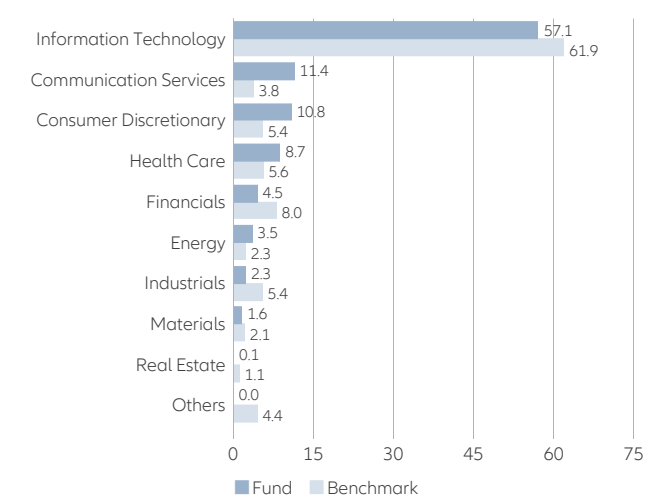

Portfolio Structure ¹⁰

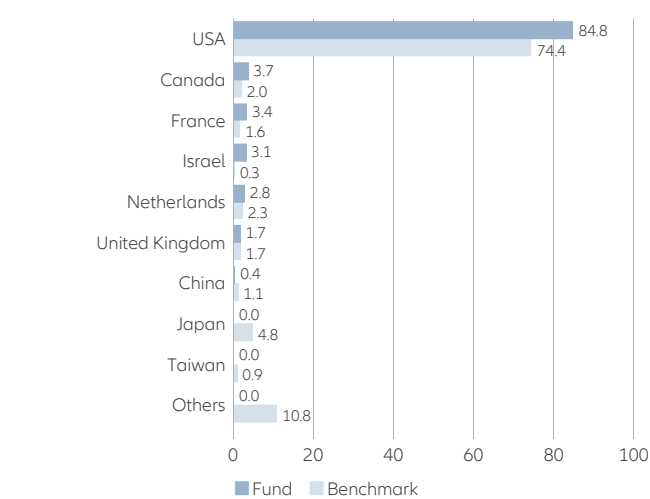
Sector Breakdown (%)
