Fund manager's report

Investment grade corporate bond markets were strong in June, generating some impressive returns as spreads moved tighter and government bond yields fell. The All-Maturities Sterling Corporate Index delivered a return of 1.4% and the euro-denominated equivalent index was up by more than 1.5% as spreads tightened 14 and 13 basis points (bps) respectively. In both markets, lower-quality and longer-dated areas were the strongest performers. The insurance sector was an outperformer in both currencies. in both currencies.

The Aberdeen Corporate Bond Fund delivered robust returns. Fixed income markets rallied strongly following dovish comments The Aberdeen Corporate Bond Fund delivered robust returns. Fixed income markets rallied strongly following dovish commen from the European Central Bank and the US Federal Reserve suggesting some further monetary easing. Government bond yields and credit spreads fell as investor demand for income-generating assets rose significantly. A long duration position, which was added to over the month, and an overweight position in higher-yielding areas of the market both made positive contributions to returns. The Fund remains overweight in higher-yielding areas of the credit market. These performed well, adding value. Financials were among the strongest performers and overweight exposure to issuers such as Aviva plc and Lloyds Banking Group were beneficial. Late in the month Tesco plc, the UK retailer, was upgraded by Moody's to investment grade. This prompted a rally in the bonds, also boosting returns. The Fund's credit positioning has been increased modestly in recent weeks as valuations remain relatively attractive. As the UK 10-year gilt yield moved towards 0.75%, a small amount of duration was taken out of the Fund duration was taken out of the Fund.
