## Investment objective


The Fund aims to provide a monthly income together with growth in the long term, which is a period of five years or more.

## Investment strategy

To achieve its objective the Fund will invest at least 80% of its value in a combination of shares (equities) of UK companies and bonds issued by UK companies. UK companies are those that are based in the UK or earn at least 80% of their revenue from the UK. Under normal market conditions, the asset allocation of the Fund is 70% in shares of companies and 30% in bonds. These percentages will fluctuate based upon market movement. The Fund is managed with reference to the FTSE All-Share Index and Markit iBoxx GBP Corporates Index. The FTSE All-Share Index and Markit iBoxx GBP Corporates as part of our investment risk monitoring process, to check that the overall level of risk taken by the fund manager is not inconsistent with the UK equities market and sterling corporate bond market. The performance of the Fund is therefore shown against the performance of a combined benchmark consisting of a weighting of 70% FTSE All-Share Index and 30% Markit iBoxx GBP Corporates Index.

## A Main risks





## Monthly performance commentary

### Equity

At sector level, stock selection was negative for the month. Positive performance came from Basic Materials and Health Care, though this was offset by negative stock selection in Consumer Discretionary and Industrials.

Basic Materials security, GLENCORE PLC with total effect 0.25% was the top contributor. Additionally, Financials security, BARCLAYS PLC was the second largest contributor with total effect 0.24%. Consumer Staples security, RECKITT BENCKISER GROUP PLC also contributed with total effect 0.23%.

On the other side, detractors included Consumer Discretionary security BARRATT DEVELOPMENTS PLC with total effect -0.28%, Industrials holding, ROLLS-ROYCE HOLDINGS PLC with total effect -0.25%, and Consumer Discretionary holding, TAYLOR WIMPEY PLC with total effect -0.20%.

During this period, no positions were opened or closed.

Sector allocation effects are residual to stock selection. At sector level, effects were positive, given an overweight exposure to Industrials.

### Fixed Income

The fixed income assets value decreased in February by -0.66%, underperforming the benchmark by 2bps. Global government bond yields rose over the month, as central bankers endeavored to pare back expectations of near-term rate cuts amid unexpectedly strong economic growth. IG, HY and EM credit markets tightened over the month.

#### Outlook

February was a strong month for credit markets. Global investment grade (IG) tightened 4bp as measured by the Bloomberg Global Aggregate Corporate Index while global high yield (HY) tightened 36bp according to the ICE BofA Global High Yield Index. Emerging markets (EM) performed strongly, with JP Morgan's Emerging Bond Index Global Government Index tightening 29bp while EM IG tightened 12bp and EM HY tightened 68bp. Asia HY generated a positive return of around 2%.

Generally, we remain modestly constructive on the overall credit outlook. Overall, we think spreads across all currencies are beginning to look tighter from a valuation perspective and so we have trimmed down some risk from portfolios. The market continues to remain fixated on when, and by how much, the Fed will cut interest rates. The bias is to continue maintaining an overweight carry positioning, given that both yields and spreads in certain pockets of the credit market continue to offer attractive opportunities.
