#### Objective


To generate growth over the long term (5 years or more) by investing in Asia Pacific, including Japan equities (company shares).

The ACD believes this is an appropriate target for the fund based on the investment policy of the fund and the constituents of the index.

#### Portfolio securities

#### Management process

- The management team use their discretion (active management) to maintain a diverse asset mix at country, sector and stock level.
- Their primary focus is on stock selection using research techniques to select individual holdings.
   The research process is focused on finding high quality companies at attractive valuations that can be held for the long term.
- In seeking to achieve the Performance Target, the MSCI AC Asia Pacific Index is used as a reference point for portfolio construction and as a basis for setting risk constraints. The expected variation (tracking error) between the returns of the fund and the index, is not ordinarily expected exceed 12.5%. Due to the active nature of the management process, the Funds performance profile may deviate significantly from that of the MSCI AC Asia Pacific Index.
