Objective

To generate income and some growth over the long term (5 years or more) by tracking the return of the JP Morgan GBI Global Index (Hedged to GBP).

Performance Target: To match the return of the JP Morgan GBI Global Index (Hedged to GBP) (before charges). There is no certainty or promise that the Performance Target will be achieved. JP Morgan GBI Global Index (Hedged to GBP) (the "Index") is a representative index of the global market for government bonds.

Portfolio Securities

- The fund will invest at least 90% in government bonds (which are like loans to government that pay interest) that make up the Index.
- The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.
- The Fund can invest 35% or more in bonds issued by a single government.


