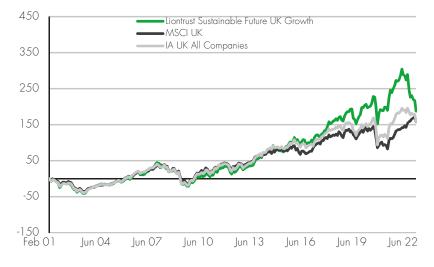


Cumulative performance (%)
