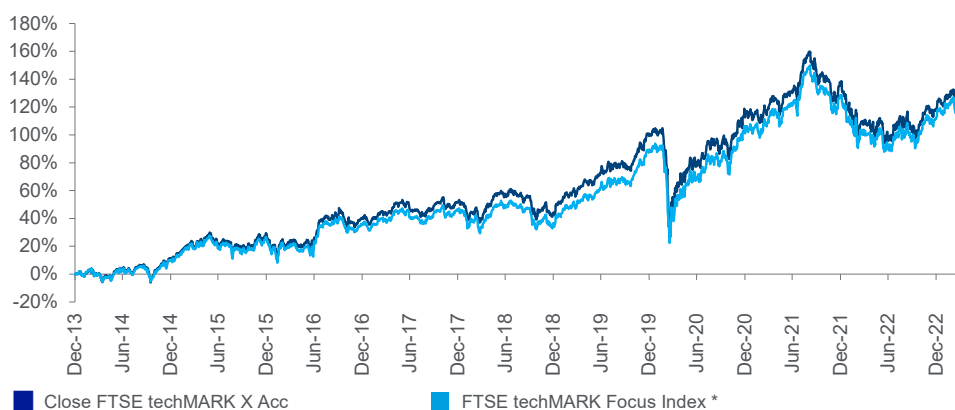
Fund objective
