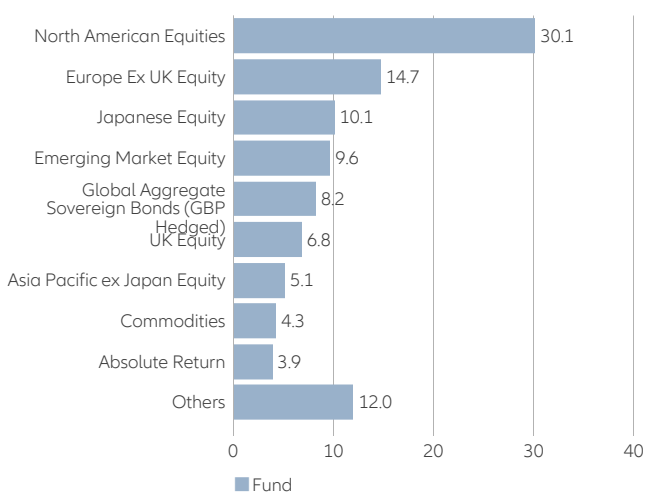

The reason we choose to use derivatives in the Allianz RiskMaster funds is to reduce costs to clients and benefit from greater liquidity. We take the risks posed by this instrument very seriously and have extensive experience in managing exposure of this nature.
