Investment Aim

The Fund seeks long-term total return (meaning capital growth and income) by investing primarily in a concentrated portfolio of shares (or securities that are similar to shares) of Russian companies. The companies issuing these shares have a registered office and official stock-market listing in Russia, or carry out most of their business there. The Fund can also invest up to 10% of its assets in collective investment schemes. There aren't restrictions on the market values of the companies held in the Fund. See the Prospectus for a full description of the investment objectives and derivative usage.

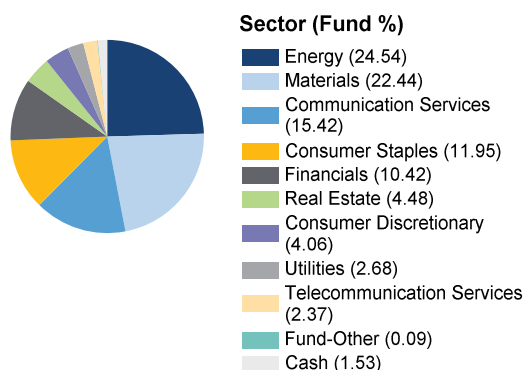
