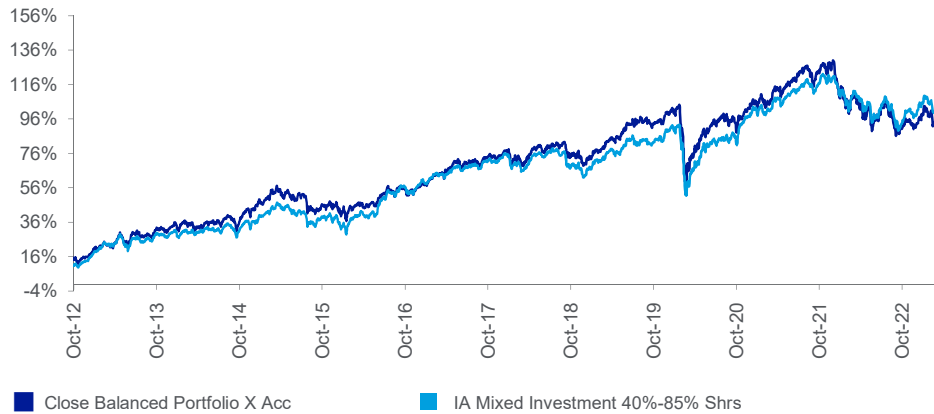
## Fund objective
