 - Reviewed on a quarterly basis

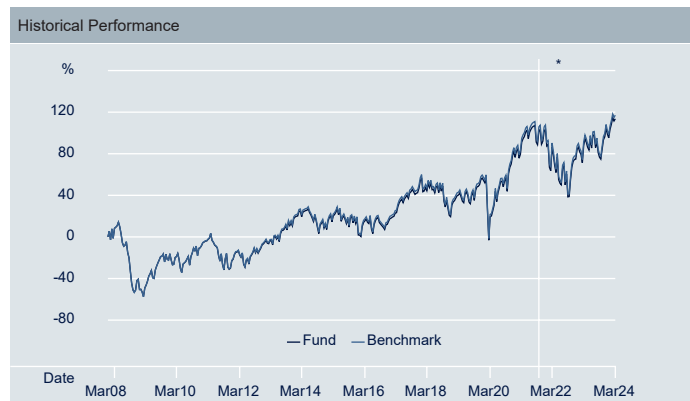
