## INVESTMENT OBJECTIVE

The objective of the fund is to achieve long term capital growth (at least 5 years) through investing in the shares of UK companies listed in the United Kingdom.

## INVESTMENT PROCESS

The fund uses a systematic investment process to identify profitable and growing companies which are assessed as trading below their intrinsic value.

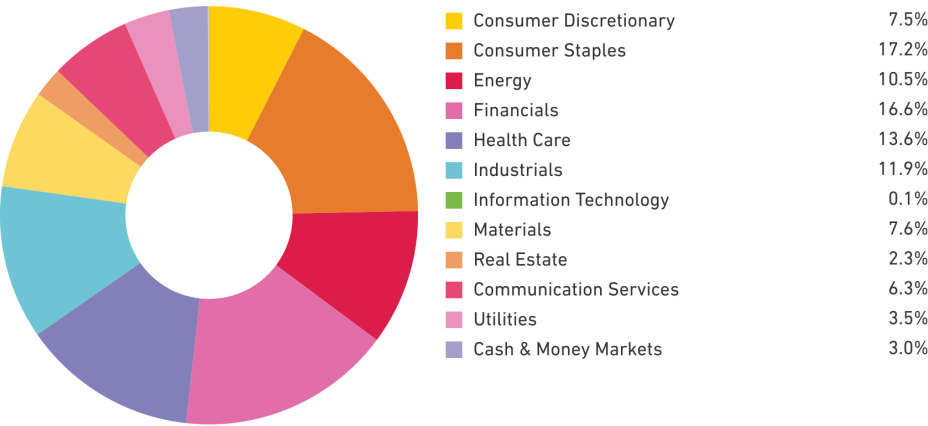
