Objective

To generate income and some growth over the long term (5 years or more) by investing in sterling-denominated bonds.

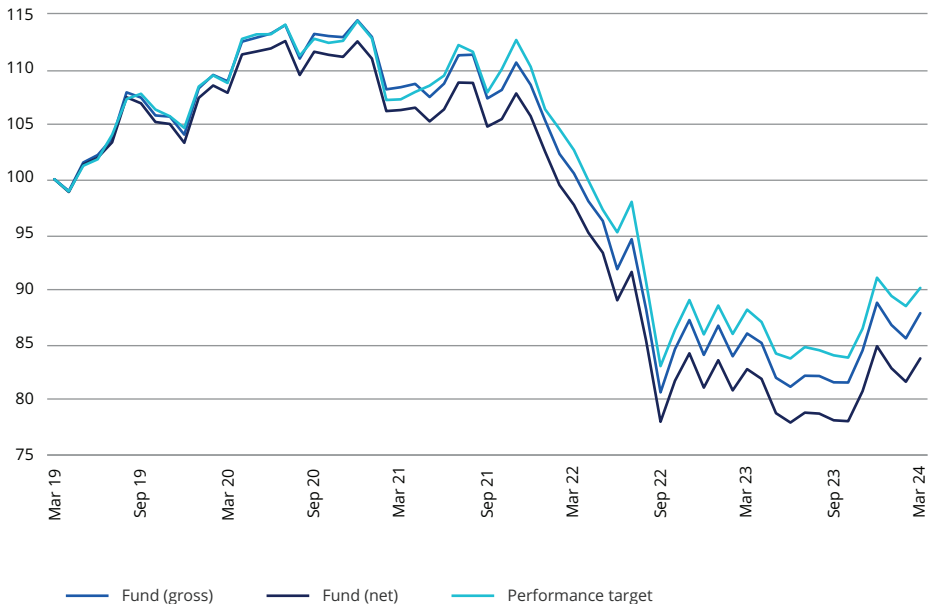
Performance Target: To achieve the return of the Markit iBoxx Sterling Overall Index plus 1% per annum (before charges). There is no certainty or promise that the Performance Target will be achieved.

The Markit iBoxx Sterling Overall Index (the "Index") is a representative index of the market for sterling denominated investment grade bonds.

Portfolio securities

- The fund will invest at least 80% in sterling denominated investment grade bonds (which are like loans to governments, government-related bodies and companies that pay interest and are typically regarded as having a low default risk) issued anywhere in the world.
- The fund may also invest in other bonds issued anywhere in the world, including high yield bonds (which are like loans to companies or governments that pay a high rate of interest but have a lower credit rating than investment grade bonds). The fund has some flexibility to seek returns from currencies.
- The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.

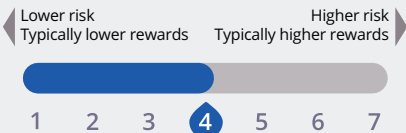
