#### Objective

To generate a positive return through capital growth and income over the long term (5 years or more) by investing in a globally diversified portfolio of assets whilst reducing the risk of losses. Invested capital is however at risk and there is no guarantee that this will be attained over any time period.

**Performance Target:** To exceed the return of SONIA by 5% per annum over rolling five year periods (before charges).

There is no certainty or promise that the Performance Target will be achieved. SONIA is the Sterling Overnight Index Average and is the representative rate for the return on cash deposits.

#### Portfolio securities

- The fund invests globally in a range of asset classes, derivatives, cash and assets that can be turned into cash quickly.
- The fund may also invest in other funds (including those managed by abrdn) to gain exposure to a broad mix of assets from across the global investment universe.
- Asset classes that the fund invests in may include equities (company shares), high yield bonds (which are like loans to companies that pay a high rate of interest, but have a low credit rating), emerging market bonds, and investment trusts (providing access to a diverse mix of others assets including infrastructure, property company shares and private equity holdings).



- The management team (the "Team") use their discretion (active management) to identify a diverse
  mix of investments which they believe are most appropriate for the investment objective. As a
  result of this diversification, and during extreme equity market falls, we expect losses to be lower
  than those of the wider global equity markets.
- The Team select individual holdings depending on their prospects for growth and income and/ or creditworthiness (debt repayment ability) compared to that of the market based on expected future economic and business conditions.
- The Team separately conduct extensive research to identify the most appropriate type of investment for each asset class.

- (d) Private Markets Risk (UCITS funds) The fund invests in companies that are listed on stock markets. The value of these companies is driven by the growth and performance of the underlying private market assets in which they invest.
