Objective

To generate income and some growth over the long term (5 years or more) by investing in sterling-denominated bonds with a high degree of creditworthiness.


Performance Target: To achieve the return of the Markit iBoxx Sterling Non Gilts AAA plus 0.65% per annum over rolling three year periods (before charges). There is no certainty or promise that the Performance Target will be achieved.

The Markit iBoxx Sterling Non Gilts AAA Index (the "Index") is a representative index of the market for sterling denominated AAA rated bonds, excluding bonds issued by the UK Government.

Portfolio securities

- The fund will invest at least 60% in sterling denominated bonds (which are like loans to companies or governments that pay interest).
- The fund may invest in bonds issued anywhere in the world by governments and corporations. The fund will employ techniques to reduce (hedge) risk related to currency movements on non-sterling bonds.
- At the point of investment, bonds shall have a credit rating of 'AAA-' or higher from at least one
 major rating agency such as Standard & Poor's, Moody's or Fitch, with the exception of any UK
 Government bond held by the fund (up to a 20% limit).
- The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.
