What is this product?

Type:

The Company is a closed-ended investment company whose shares are listed on the premium segment of the Official List of the UK Listing Authority and traded on the main market of London Stock Exchange. The Company's ordinary shares are therefore available to the general public.

Shares of the Company are bought and sold via markets. Typically at any given time on any given day, the price you pay for a share will be higher than the price at which you could sell it.

Objectives:

To grow money invested in the company and provide an income to investors, both over the long term, through investment predominantly in companies exposed directly or indirectly to Emerging Markets and Frontier Markets worldwide.

The Company will invest -

- At least 70% of total assets in companies that, have their registered offices or principal places of business in emerging markets or frontier markets, or which exercise a material part of their business in emerging markets and/or frontier markets.
- No more than 25% of total assets invested in companies that have their registered offices or principal places of business in, or which exercise a material part of their business in frontier markets.

Emerging market countries shall consist of all those countries which are included in the MSCI Emerging Markets Index at the time of investment. Frontier market countries shall consist of all those countries which are not included in the MSCI Emerging Markets Index or the MSCI Developed Markets Index at the time of

investment. Generally, the investment adviser considers frontier markets to be smaller, less well established economies that are at an earlier stage of economic and political development than emerging markets. There are no limits placed on exposure to any one geographical area, however, the investment adviser will invest and manage the portfolio in a manner consistent with spreading investment risk.

The Company has the power to use derivative instruments for investment purposes. Derivatives allow the Investment Adviser to track changes in the price of an item, for example a company share, without actually owning it. Derivatives may be used to gain exposure to a number of different asset classes, including company shares, financial indices, commodities and currency exchange rates. The Company may also use derivatives to reduce risk.

The Company has a flexible loan facility it can use for investment purposes (known as gearing) with a view to enhancing returns. The maximum level of gearing will be 20% of the Company's total assets at the time of initiating the loan. The Company is not restricted to investing in constituent companies of the Benchmark (MSCI Emerging Markets Index).

This product has been designed to form part of a broader portfolio of investments and should be purchased with advice or on an execution only basis by an investor.
