WHAT IS THIS PRODUCT	
Туре:	The Company is a closed-ended investment company whose shares are listed on the London Stock Exchange and an alternative investment fund under the Alternative Investment Fund Managers directive. The Company's shares are therefore available to the general public.
Objectives:	To provide investors with a sustainable and inflation-linked quarterly dividend and to aim to preserve and where possible enhance capital value through the reinvestment of excess cash flows not required for the payment of dividends in a diversified portfolio of predominantly UK ground-based solar PV assets. The Company will pursue its investment objective by acquiring ground based, operational solar power plants predominantly in the UK.
Intended retail investor:	The Company is suitable for all investors seeking a fund that aims to deliver a sustainable and inflation-linked quarterly dividend, and to preserve and where possible, enhance capital value. The investor should be prepared to bear losses and accept the risk inherent in the Company's investment policy. The Company is compatible for mass market distribution.
Notes:	The Company has incurred gearing to acquire ground based solar power plants in accordance with the investment policy.
