

Key Information Document

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

Premier Miton Global Renewables Trust PLC Ordinary Shares (ISIN GB0033537902) (the Company or the Product). The Product changed its name from Premier Global Infrastructure Trust on 16 November 2020. The manufacturer of the Product is Premier Portfolio Managers Limited which is authorised and regulated by the Financial Conduct Authority in the United Kingdom. Its website is www.premiermiton.com. What is this product?

Type

The Product is an ordinary share issued by Premier Miton Global Renewables Trust PLC. Shares in the Company are admitted to trading on the London Stock Exchange where they can be bought and sold. Typically, at any given time on any given day, the price you pay for a share will be higher than the price at which you could sell it.

Objectives

The Company's investment objectives are to achieve a high income from its portfolio of investments and to realise long-term growth in the capital value of this portfolio. The Company will seek to achieve these objectives by investing principally in equity and equity related securities of companies operating primarily in the renewable energy sectors as well as other sustainable infrastructure investments. Unlike cash, the Company's portfolio includes different types of investments that are not guaranteed and the value of the ordinary shares and any dividend income derived from them may fall or rise over any period. The Company therefore believes the recommended minimum holding period for the Product is five years.

The Company uses gearing as an investment strategy which means that movements in the price of the Product may be more volatile than the movements in the price of the underlying investments if the investments are subject to sudden and large falls in value and investors may get back nothing at all if there is a sufficiently large fall in value of the underlying investments. Gearing is provided by Zero Dividend Preference shares issued by the Company's subsidiary PMGR Securities 2025 PLC. The Zero Dividend Preference shares are redeemable on 28 November 2025. The Company's investments are actively managed, but always within the boundaries outlined in the Company's objective and policy, as set out in more detail in the prospectus.

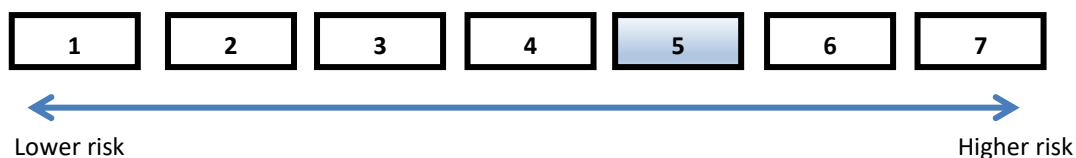
Intended Retail Investor

The Product is intended for investors who are seeking regular income and capital growth, can afford to invest for at least five years or more and who understand that there are no guarantees on the return of their original investment when they come to sell their investment. The Company has a continuation vote every five years, with the next one due in the first half of 2025. An investment in shares should constitute part of a diversified investment portfolio. Typical investors are expected to be institutional investors and individuals who have received advice from their financial adviser, fund manager or broker regarding investment in shares or individuals who have not taken advice but have previous experience of investing in this type of product and can make an informed investment decision based on their knowledge and understanding of the risks involved.

What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets.

Risk Indicator



The risk indicator assumes you keep the Product for five years. The actual risk can vary significantly if you sell your investment at an early stage and you may get back less than you invested. You may not be able to sell your shares easily or may have to sell at a price that significantly impacts on how much you get back.

The product is classified as 5 out of 7, which is a moderate-high risk class.

This rates the potential losses from future performance at a moderate-high level and poor market conditions are likely to impact the value of the investment. The value of your investment is driven by the price of the product on the stock market. This means

that the value of your investment may go up and down as the value of the Product's share price changes. Income generated by the Company may be paid through dividend distributions, at the discretion of the Company's directors.

The companies in which the Company invests are, in general, exposed to a higher level of political and regulatory risk, than companies in stock markets as a whole. Renewable energy companies may be exposed to changes in market prices for their electrical output, or to changes in subsidy levels or regulatory regimes. Many renewable energy companies sell power on long term offtake contracts and are exposed to credit risks from their counterparties. In certain countries, the regulatory framework governing the construction of renewable energy assets, and the sale of electricity produced by those assets, is still developing and may change in future making it harder to develop new assets. In certain countries renewable energy is sold on long term fixed price tariffs and contracts, the present value of which could be eroded by increases in the rate of inflation. A full description of the principal risks is contained in the Annual Report and Accounts, which can be found on the Company's website. The Product does not hold any protection from future market performance so you could lose some or all of your investment.

Performance Scenarios

Market developments in the future cannot be accurately predicted. The scenarios shown are only an indication of some of the possible outcomes based on recent returns. Actual returns could be lower. This table shows you the money you could get back over the next five years, or over shorter periods, under different scenarios, assuming that you invest £10,000. The tax legislation of the country/ies in which you are resident for tax purposes may have an impact on actual pay-out.

Presentation of costs

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the Product itself, for three different holding periods. The figures assume you invest £10,000. The figures are estimates and may change in the future.

How long should I hold the Product and can I take my money out early?

The recommended holding period is at least five years. Investors holding the Product do not have a right for their shares to be redeemed. The Product is admitted to trading on the London Stock Exchange and can be bought or sold on any day the market is open. If you seek to sell your shares urgently you may have to sell at a price that significantly impacts on how much you get back. To sell your shares you will need to contact your authorised financial adviser, broker or a share dealing service.

How can I complain?
