You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Objectives:

WisdomTree Brent Crude Oil 1x Daily Short is designed to enable investors to gain a 'short' exposure to a total return investment in Brent crude oil futures contracts by tracking the Bloomberg Brent Crude Oil SL index (the "Index") and providing a collateral yield. The product is designed to give investors a negative or inverse exposure to the Index. For example, if the Index was to rise in value by 5% on a particular day, the product is designed to decrease in value by 5% on that day (minus fees and expenses) and if the Index was to fall in value by 5% on a particular day, the product is designed to increase in value by 5% on that day (minus fees and expenses). For periods of longer than one day, the return of the product is not the same as the return of the Index multiplied by a factor of minus one (the "Leverage Factor"). This is because the Leverage Factor is reset on a daily basis (i.e. the Leverage Factor is applied to the performance of the Index on each day). The daily reset has a "compounding effect" which means that, the more volatile the performance of the Index, the more the performance of the product will deviate from the performance of the Index (multiplied by the Leverage factor) over a given period of time. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts. The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. The ETP is backed by swaps with Citigroup Global Markets Limited and Merrill Lynch International. The payment obligations of the swap counterparties to the Issuer are protected by collateral held in a segregated account at an independent custodian, The Bank of New York Mellon.

Intended retail investor:

The product is intended for informed retail investors who: (i) can bear loss of capital, are not seeking to preserve capital and who are not looking for capital guarantee; (ii) have specific knowledge or experience of investing in similar products and in financial markets; and (iii) seek a product offering short exposure to the performance of the underlying asset(s) and have an investment horizon in line with the recommended holding period stated below.
